- Residents eligible for membership cannot be signed in as guests
- Members **MUST** be with their guests at all times. The member must arrive before their guests and remain in the park with their guests at all times.
- For more than five guests, up to a maximum of 8, a Gate +8 List form must be completed and returned to the Auburn House Administration Office at least 48 hours prior to your event for approval.
  - Gate +8 Lists are accepted and approved on a first come first served basis. Auburn House accepts a maximum of 10 Gate +8 Lists per day, Monday through Thursday (not including stat/civic holidays) and 5 Gate +8 Lists per day, Friday through Sunday (and all stat/civic holidays).
  - Members are permitted to submit one Gate +8 List per household per day.
  - Members and their guests **MUST** check in at the Gatehouse (between 11am – 7pm). For lists between 9am – 12pm, and after 7pm, check in at the Main Entrance.
- ABRA has the right to decline any group.
- Gate +8 List forms are available from the Administration Office and on AuburnBayRA.ca. Maximum number of guests is 8.
- Gate +8 List only permit entrance and use of the park and lake. Guests signed in with a Gate +8 List **do not** have access to the gym or the outdoor courts.

# Important Rules of Auburn House/Lake/Park



## General Rules:

- All members (12 years of age and older) must have their lake card with them to enter the facility.
- No child under the age of 12 is permitted in the park without an adult.
- No animals, glass, smoking, or alcohol permitted.
- Bicycles, scooters, rollerblades, roller skates, skateboards, etc. are not allowed in the park.
- Open fires are not permitted. Charcoal briquettes may be used in the picnic shelter barbeques.
- Members must refrain from using foul language in the park and rambunctious and unsafe behavior will not be tolerated.
- Alcohol, glass bottles and smoking (including cannabis and vaping) are strictly prohibited in the park.
- The use of motorized boats or other vehicles is prohibited (except as required by the ABRA for maintenance or security purposes).

## Lake/Swimming:

- Jumping or diving from any dock owned by the ABRA or from any boat is strictly prohibited.
- Swimming is only permitted in the designated swimming area.
- Use of boogie boards or other such types of equipment will be allowed only when nobody is on the beach or in the swimming area.

## Boat Rentals:

- Residents must be in a rented boat with their guest(s).
- Members under the age of 16 will not be permitted the use of a boat unless they are accompanied by an adult member.
- Life jackets are mandatory.
- Jumping out of any boat is prohibited.
- Always return your boat to the public dock you received it from (not to the beach shore).

## Fishing:

- Members/guests bringing in fishing rods must enter the park through the main entrance.
- Daily take home limit is two fish and monthly take home limit is twelve fish per household.
- No fishing from any public dock.
- No live bait or any type of food is to be used.
- Do not clean your fish in the boats or anywhere in the park.
- When ice fishing, do not drill/auger within four meters (thirteen feet) of any prepared ice surface.

## Winter/Skating:

- When thin ice signs are posted, you must stay off of the lake/ice.
- Hockey sticks and pucks are only permitted on the hockey rinks (not the pleasure rink).
- Nobody is allowed on the ice while the Zamboni or other equipment is servicing the ice.
- Tobogganing is permitted in designated areas only.

**The Auburn Bay Residents Association does not provide supervision or lifeguards for park/lake use. Guardians are responsible for their children at all times. Members and guests will enter and use the park facilities at their own risk. Abuse of any kind towards Auburn House staff will not be tolerated. City police will be immediately contacted.**
